Shipment:

LTL

- **Requirements:**
 - Carton dims =>165 inches in length & girth combined
 - Carton length => 108 inches
 - Carton weight => 150lbs
 - Total weight (w/out pallet) is => 400lbs
 - Vendor needs pre-approval to ship LTL
 - Guaranteed shipments must be pre-requested by a Motis Brands employee
- **Routing information:** (Image listed in Appendix)
 - Transportation Management System (TMS) Superior (3rd party)
 - Contact shipping@motisbrands.com for routing template to gather TMS info below
 - Superior will route the freight
 - We do not allow partial shipments. If quantities need to be adjusted, please contact your Merchandising Manager prior to shipping.
 - Incomplete purchase orders will not be accepted and returned at your cost
- **TMS information:**
 - Motis Purchase order
 - Motis SKU number & quantity
 - Dims-inches
 - Weight –including pallet
 - Pallet count
 - NMFC item number
 - Freight & sub-classification
- **Timeline:**
 - Routing will need to be completed a minimum of 48 business hours prior to the start ship window
 - Superior will respond with tendered assignment within 24 hours of routing submitted
- **Reminders:**
 - Cancellation or routing change: Notify shipping@motisbrands.com prior to the start cancel ship window
 - Missing freight class or misclassification will prevent the rating & scheduling of the load

Shipment:

Parcel- Ground:

- **Requirements:**
 - Carton dims < 165 inches in length & girth combined
 - Carton length is < than 108 inches
 - Carton weight <150lbs
 - Total weight is <400lbs
 - Fed Ex is the authorized carrier of choice

- **Routing information in Fed Ex:** (Image listed in Appendix)
 - 6 -digit purchase order is required
 - Go into Fed Ex website
 - Log in under your vendor name
 - Click on the ship tab
 - Click on the down arrow in Service type field, located on the right side of the page, under package and shipment details- choose **Fed Ex ground**
 - Click on the down arrow in the bill shipment to field, located on the left side of the page, under billing details
 - Chose collect (ground only)

- **Timeline:**
 - Routing will need to be completed the same day as desired pickup

- **Miscellaneous:**
 - Fed Ex account # will be provided by the Merchandising team once account has been set up

- **Reminders:**
 - Any carton exceeding the limitations of Fed Ex's unauthorized oversize charge will result in a surcharge to the Supplier
 - Insurance- Do not purchase declared value using Motis Brands 3rd party billing account
 - Motis Brands will not pay freight charges billed through other parcel carriers

Special Shipments:

Expedited/Air Shipments:

- **Requirements:**
 - Expedited service must be listed on the purchase order
 - Service must be requested by a Motis Brands agent & be pre-approved

Proposition 65 Regulation:

- **Requirements:**
 - The State of California requires warnings be provided on products which contain chemicals that are listed under Proposition 65 regulation.
 - In compliance with these regulations, Motis Brands is requiring our suppliers to fill out a Proposition 65 worksheet (image located in the Appendix section) for all items we purchase from you, indicating if there is any chemical from the Proposition 65 list used to make the product. Contact your Category Managers if you need access to the form or have any questions.

Hazardous Material (Hazmat):

- **Requirements:**
 - It is the responsibility of the shipper to identify product that is deemed hazardous material and to notify Motis Brands shipping@motisbrands.com
 - Product should be flagged in the routing process by selecting Hazmat
 - Carton labels should have external stickers indicating Hazmat

- HAZARDOUS MATERIAL - A substance or material, including a hazardous substance, which has been determined by the Secretary of the Department of Transportation to be capable of posing an unreasonable risk to health, safety, and property when transported in commerce, and which has been so designated. (See 49 CFR 171.8)
 - MULTIPLE HAZARDS - A material meeting the definition of more than one hazard class and must be classed according to its position on the list in 49 CFR 173.2(a).

Prepaid Shipments

- **Requirements:**
 - Vendor bears all responsibility for prepaid shipments including payment to carrier

3rd Party Drop Ship Shipments

- **Requirements:**
- If the shipment is under 6 pallets
 - Vendor needs to fill out the form "DROP SHIPMENT REQUEST"
 - Completed form needs to be emailed to roxanne@superiortranslog.com
 - The BOL will be emailed back to the sender and carrier scheduled
 - Pickups will take place same day or next business day
- If the shipment is 6 or more pallets
 - Vendor needs to fill out the form "DROP SHIPMENT REQUEST"
 - Completed form needs to be emailed to shipping@motisbrands.com
 - The BOL will be emailed back to the sender and carrier scheduled
 - Pickups will take place in 1-2 days

BOL- Bill of Lading (Image listed in Appendix)

- **Requirements:**
- Vendor must use the GS1 Standard Bill of Lading (BOL)
- Vendor name as it appears on the original purchase order must be referenced on the (BOL) as the actual shipper
- (BOL) are required in a PDF format within 24 hours of shipment arrival to Motis Brands warehouse domesticinbound@motisbrands.com
- Information needed:
 - Purchase order #
 - Date of pickup
 - Carrier name
 - Trailer #
 - Driver signature

Delivery:

Live Unload

- **Requirements:**
 - 10 pallets or= <
 - Vendor/Supplier is responsible for contacting shipping@motisbrands.com to schedule a delivery appointment
 - Appointment must include: carrier date & time of delivery
 - Carrier must wait for confirmation & authorization # before delivering
 - (BOL) are required in a PDF format within 24 hours of shipment arrival to Motis Brands warehouse shipping@motisbrands.com

Drop Trailer

- **Requirements:**
 - > 10 pallets
 - (BOL) are required in a PDF format within 24 hours of shipment arrival to Motis Brands warehouse shipping@motisbrands.com

Motis Carton Label (Image listed in Appendix)

- **Requirements:**
 - Each carton that contains product must be labeled with Motis Brands Article /SKU numbers which are provided to you
 - This SKU might be different than your own internal SKU #
 - Motis Brands uses different numbers for every style, size & color
 - Barcode must represent all product digits for every article number
 - Only one barcode from Motis Brands should be located on the carton
 - Consist of any code but code39
 - Size minimum of 14x70mm (24 point Times Roman Font)
 - label size- should be 4x6 inches
 - label placement- on all sides of the carton in the upper right hand corner


